1. The letter mail service is for **all countries of the world except Israel**.
2. The maximum limit of weight of a letter mail item for transmission by post to any country shall be **two kilogram (2 kg)**.
3. The revised tariff shall be applied on all **types which fall in letter mail category**.
4. **No additional, Air surcharge** shall be levied on letter mail tariff.
5. **Postage Stamps shall not be affixed** on registered letters. The amount will be collected in cash and receipt will be issue to the customer.
