Suitable Notice will also be exhibited prominently on the office Notice Board by the newly authorized Post Office for the information of the general public.

The EP Services when started at the above Post Office will be intimated by the Head of Circle to the Directorate General promptly for issuance of amendments/corrections in the List of Cities/Towns/Post Offices linked with Express Post Network in Pakistan as contained in Para 3 (a) of DG's Special Circular No.06 dated 15-05-2008 for information of all concerned.
