SUBJECT: - EXTENSION OF EXPRESS POST SERVICES AT NEW STATION/LOCATIONS.

Reference: - Your office letter No. EP/Ums Rating/21-22 dated 23-02-2024.

The Director General has been pleased to allow provision of EP Service (UMS) with existing infrastructure and man power at Al-Mohafiz Post Office, under Bahawalpur GPO with immediate effect.

2. The Postmaster General, Southern Punjab Circle, Multan will arrange to provide a copy of the relevant Director General Special Circular with all amendments made therein from time to time as well as other pertinent instructions to the newly authorized Post Office to enable it to run the above-mentioned EP Service properly and efficiently.

3. The Chief Postmaster, Bahawalpur GPO will urgently arrange to provide standardized printed forms, relevant books of receipts, UMS service stationery, etc to the above said post Office for commencing the operations of newly introduced Service.

4. Local publicity will also be arranged by the Unit Officer and In-Charge of Post Office for information of the prospective users of EP Services. Suitable Notice will also be exhibited prominently on the office Notice Board by the newly authorized Post Office for the information of general public.

5. The EP Service when started at the above Post Office will be intimated by the Head of Circle to the Directorate General promptly for issuance of amendments/ corrections in the List of Cities/Towns/Post Offices linked with Express Post Network in Pakistan as contained in Para 3 (a) of DG's Special Circular No. 06 dated 15-05-2008 for information of all concerned.
